## **Voluntary Protection Programs**

- Virginia Voluntary Protection Programs (VPP) are five programs designed to recognize and promote exceptional safety and health management programs.
- Management and labor establish a cooperative relationship at a General Industry, Construction or Public Sector workplace that has implemented a strong safety and health program.
  - Requires 3-year TCIR & DART <u>below</u> industry average
- Elements of a successful SHMS will focus on:
  - Management Leadership and Employee Involvement
  - Worksite Analysis
  - Hazard Prevention and Control
  - Safety and Health Training



#### **Voluntary Protection Programs**

- VOSH verifies the program meets VPP criteria, publicly recognizes the site's exemplary program, and removes the site from the programmed compliance inspections.
- The VPP concept recognizes enforcement alone can never fully achieve the objectives of the Occupational Safety and Health Act. Good safety management programs that go beyond VOSH standards can protect workers more effectively than simple compliance.
- VOSH also reassesses periodically to confirm the site continues to meet VPP criteria.








#### **STAR** (General Industry)

- First STAR Worksite in 1996 (GE Salem)
- 73 Worksites achieved VPP
- 38 Active STAR sites
  - 29 Different companies 17 Different industries








#### Virginia Challenge (General Industry)

- Three Stage program
  pathway to STAR
- Advance at your own pace to improve SHMS
- 13 active sites including Public and Private sector







#### Department of Corrections (DOC) Challenge (Public Sector)

- Established 2018
- VA DOC established, funded, and staffed a dedicated, stand-alone Safety Department
- Eight active sites
- Mentor other Virginia State agencies in pursuit of STAR



# Virginia BEST

(Construction)

- Strategic Partnership With Associated General Contractors of Virginia (AGCVA)
- Signed agreement in 2018
- Established AGC Review Board for vetting of candidates
- Required AGCVA review
  with VOSH approval
- Highest Level (Level 3) provides State exemption for all the participants in VOSH jurisdiction in Virginia

## Virginia BUILT

(Construction)

- Strategic Partnership With Associated Builders Contractors of Virginia (ABCVA)
- Signed agreement in 2020
- Established ABC Review Committee for vetting of candidates using ABC STEP as entry requirement
- Required ABCVA review with VOSH approval
- Highest Level (Tier III) provides State exemption for all the participants in VOSH jurisdiction in Virginia





#### Why Take the VPP Journey?

- Improved safety performance
  - STAR sites are on average 52% below BLS TCIR and DART.
  - Fewer injuries and illnesses mean greater profits as workers' compensation premiums and other costs plummet.
  - Entire industries benefit as VPP sites evolve into models of excellence and influence practices industry-wide.
- Increased employee morale
  - The cost of replacing an employee can be substantial, often amounting to 6-9 months of the employee's salary.
    - Recruitment, onboarding, and training expenses.
    - Hidden costs involve project disruptions, increased workload for existing staff, and potential morale decline.



#### Why Take the VPP Journey?

- Economic benefits
  - A medically treated injury direct costs equal \$44,000!
  - U.S. work injuries cost \$167 Billion in 2022, (NSC).
  - A workplace <u>injury</u> takes place every <u>six seconds</u>, which means <u>89,000 each week</u>, (NSC).
- Enhanced public recognition
  - VPP participants are exempt from OSHA <u>programmed</u> inspections while they maintain their VPP status.
- Benchmarking
  - Development of cooperative relationships.
  - Competitive advantages for your entire organization.



#### The Safety and Health Achievement Recognition Program (SHARP) recognizes employers with exemplary safety and health management systems

- You are eligible for SHARP if you:
- Have no more than 250 employees at the site and not more than 500 total employees at all sites.
- Are a single, fixed worksite.
- Have at least one full year in operation.
- Have a Lost Workday Injury and Illness (LWDII) rate and a Total Recordable Case Rate (TRCR) below that for your industry.
- Are on VOSH's high hazard inspection list, or have a NAICS on any emphasis program list at the national, state or local level.






















